The Marquette Downtown Development Authority allows consumption of alcoholic beverages for rentals at the Marquette Commons by special permit only. The following are rules and regulations that must be acknowledged before an alcohol permit is issued:

- The individual applying for the alcoholic beverage permit must be at least 21 years of age and must be in attendance at the event at all times and is responsible for ensuring that no alcohol is distributed to underage individuals.
- All members of the function consuming alcohol must be at least 21 years of age.
- The *sale* of alcoholic beverages requires a 24 hour liquor license that has to been obtained from the Michigan Liquor Control Commission, otherwise, it is strictly prohibited.
- As stated in the City of Marquette Code of Ordinances (Chapter 4, Section 4.2) alcohol is limited to beer and wine only.
- Permit is valid for date and time of designated rental only.
- Permit is valid for the Marquette Commons building only and is not valid for any other location.
- Alcoholic beverages may only be consumed inside the Marquette Commons building. Outdoor consumption requires an additional permit from the City of Marquette, otherwise, it is prohibited.
- All ordinances, rules, and regulations of the City of Marquette remain in effect and all state liquor laws must be observed.
- Permit is valid for the individual or entity to which issued and shall not be transferred.
