


MISSION

The Marquette DDA is a Public Authority established in 1976 by the City of Marquette in accordance with Michigan Public Act 197* to "prevent deterioration in business districts, encourage historic preservation, increase property tax valuation, and to promote economic growth."

*As of 1/1/18 Act 197 was replaced with Public Act 57 of 2018, which recodifies Tax Increment Financing Authorities and established additional government reporting requirements.














DOWNTOWN MARQUETTE FARMERS MARKET

ACTIVE VENDOR BREAKDOWN










AVG NUMBER OF VISITORS (Saturday Morning Market)




AVG NUMBER OF VISITORS



MATCH ON MAIN GRANT

The DDA assisted two Downtown Marquette businesses in each being awarded and completing a \$25,000 Match on Main Grant.

- Great Northern Title, Inc. completed their grant in August, with a renovation to the interior their business. This grant, combined with their additional renovations, resulted in an investment of over \$200,000 in their business.
- Velodrome Coffee Co. completed their grant in July. Their grant involved them purchasing and moving to a new location on North Third St. and helped them purchase new furniture and appliances to expand their coffee service. They also developed a garden for the café and a compost system in conjunction with Partridge Creek Farm.
- Ore Dock Brewing Co. also completed their MoM Grant, but it was awarded in a previous fiscal year.


