Businesses preparing food on-site must submit a copy of their health department license with application. Food products produced under the Cottage Food Law must conform to the regulations set forth in that legislation. All processing and packaging must be done by the vendor and have proper labeling. Tents must be non-flammable and all booths must conform to applicable fire codes.

A NOTE ON COVID-19: At Blueberry Festival, we will encourage all who attend to follow current state and local COVID-19 guidelines, including maintaining social distance, properly wear masks, frequently wash or sanitize hands, and encourage those who feel unwell to stay home. Public safety will remain the Marquette DDA's top priority at any event we host. While we will make every effort to ensure these events will take place in a safe manner, decisions and occurrences beyond our control may prohibit Blueberry Festival from going forward, including limitations on the number of individuals who can gather at an outdoor event.
