**STATE OF MICHIGAN

WHEREAS, the Michigan Department of Health and Human Services (hereinafter referred to as “MDHHS”) entered into Memorandum of Understanding effective July 27, 2022 with Marquette Downtown Development Authority (hereinafter referred to as “Marquette Downtown Development Authority”), for the provision of certain services as set forth therein; and,

WHEREAS, it is mutually desirable to MDHHS and to Marquette Downtown Development Authority to amend the aforesaid Agreement.

THEREFORE, in consideration of the promises and mutual covenants hereinabove and hereinafter contained, the parties hereto agree to the following amendment of said Agreement. This amendment shall be attached to the Agreement, said Agreement being hereby reaffirmed and made a part hereof.

Article I

This amendment shall be effective on the date of MDHHS signature.

Article II

Section 3. **Period of Agreement** shall be extended by one year, amending the agreement as follows:
